CMA SUMMER CAMP GENERAL TERMS AND CONDITIONS

1. GENERAL

An agreement is herewith entered into between you, the undersigned parent(s)/guardian(s), and CMA in respect of your child's participation in the CMA mixed gender Summer Camp that will be held in Creative Lab space at Yas Creative Hub, podium 2 in Abu Dhabi ("**Camp Location**") from 17 July 2023 to 4 August 2023 (the "**Camp**"). The Camp may include activity trips outside the Camp Location. The Camp will be conducted in both English and Arabic, therefore your child should be able to communicate in both languages.

CMA services are subject exclusively to the terms of the application form and of these general terms and conditions.

2. CAMP TIMINGS

For the first two weeks of the Camp, the Camp shall be held on weekdays from Monday to Thursday 9:00 AM to 3:30 PM during first two weeks of the camp, and from Monday – Friday on the last week, where we will have our camper's closing ceremony on Friday at 9:00 AM to 12:00 PM. You must ensure that you drop-off and pick-up your child on time.

The transport of your child to and from the Camp Location and location of the activity trip shall be your sole responsibility.

3. COST AND PAYMENT CONDITIONS

The fee for the Camp is UAE Dirhams 1,200 per child (inclusive of VAT) ("**Camp Fee**"). The Camp Fee is non-refundable in whole or in part and must be paid in full by no later than 17 July 2023. The Camp Fee includes payment for lunch and all camp activities (including equipment and materials). The Camp Fee does not cover travel to and from the Camp, personal expenses, insurance premiums or any medical treatment provided. In case of delay in payment of the Camp Fee, CMA shall be entitled to refuse admission of your child to the Camp.

4. CANCELLATIONS

If you cancel your child's participation (before or during the Camp), CMA shall be entitled to keep the entirety of the Camp Fee regardless of the reason for cancellation

(including force majeure). In the event of the Camp being cancelled by CMA (before or during the Camp), CMA shall

refund part of the Camp Fee to you (in its sole and absolute discretion).

5. BEHAVIOUR

All children taking part in the Camp must conduct themselves in line with the social and moral norms of the United Arab Emirates and must abide by all of CMA's rules and Camp regulations. In addition, children must dress in an appropriate and modest manner and must keep mobile telephones out of plain sight when participating in the Camp.

Children and/or parents must not take picture or video of the presenters or other children without prior permission of CMA.

CMA reserves the right to dismiss any child taking part in the Camp that it deems unfavorable to the smooth operation of the Camp. In the event of such dismissal, CMA is entitled to keep any and all payments made by you as way of compensation. Any additional costs incurred as a result of dismissal shall be borne by you.

6. RELEASE

In consideration of CMA allowing your child to participate in any programs, events, classes, or other activities at the Camp, you hereby waive, release and discharge for yourself, your child, heirs and executors each of CMA and its employees, agents, counselors, teachers, trainers, representatives, successors and assigns, from and against any and all rights and claims for any loss, damage, illness or injuries to person or property sustained as a result of your child's participation in the Camp.

7. INTELLECTUAL PROPERTY RELEASE

You acknowledge that CMA uses and produces photographs, videotapes, television programs, motion pictures, tape recordings, or other similar media ("**Promotional Media**") for promotional purposes. You



hereby consent to the use of your or your child's name(s) and/or your or your child's likeness(es) in such Promotional Media to be exhibited and used for advertising, trade purposes, solicitation of patronage, promotional purposes, or other similar purposes ("Promotional Purposes"). You hereby also consent to CMA sharing such Promotional Media with its partner companies in the Creative Zone – Abu Dhabi, and with other Abu Dhabi government entities, for Promotional Purposes.

You further waive any and all rights to inspect or approve the Promotional Media or other use of your and/or your child's name(s) and/or likeness(es), including any written article, script, caption or other writing that may accompany such use of your and/or your child's name(s) and/or likeness(es).

You hereby, for yourself, your child, heirs and executors, waive, release and discharge CMA and its employees, agents, counselors, teachers, trainers, representatives, successors and assigns, from and against any and all liability, claims, losses, costs, expenses or damages for libel, slander, invasion of privacy, conversion, defamation, appropriation of likeness or any other claim based on the use of your and/or your child's name(s) and/or likeness(es) in the Promotional Media or any such materials.

8. INDEMNIFICATION

You represent and warrant to CMA that you have the authority to execute this agreement on behalf of yourself and/or your child as parent or guardian. In the event of any misrepresentation or breach of the foregoing warranty by you, or in the event that you or any other person nevertheless asserts any claim against CMA arising out of your child's participation in the Camp, you agree to indemnify, hold harmless and defend CMA from and against any and all liability, claims, losses, costs, expenses or damages resulting therefrom, including, but not limited to, claims of loss, damage, illness or injury to person or property whether or not such loss, damage, illness or injury results from the negligence of CMA or from some other cause.

9. HEALTH AND SAFETY

You and your child shall at all times strictly adhere to and remain compliant with all relevant health, safety and security requirements health and safety rules, guidelines and regulations applicable in relation to any relevant local authority;

10. GOVERNING LAW AND JURISDICTION

These terms and conditions shall be governed exclusively by the laws of Emirate of Abu Dhabi and the federal laws of the United Arab Emirates as enforced therein. You agree that the courts of Abu Dhabi shall have exclusive jurisdiction to settle any dispute which may arise in connection with your child's attendance of the Camp.
